- 2. Discussed counter flashing as existing and as proposed on plans. 30-year warranty must be preserved in the solution to this condition.
- 3. The overflow drains were pointed out. In the International Building Code Section 1503.4, the overflow drains are described. However, it looks like to me that what has been done on this roof, it is doubtful they are needed. At this point, it is probably cheaper to flash the openings with rubber roofing than to close off and roof over.
- 4. Metal roof products will be Colonial Red color to match existing.
