- 1. Specification Section 23 0508, Paragraph 24, contains two statements which need to be corrected by Addendum: The refrigerant in the existing chiller is R-123. This will not be removed by Unit 5 District employees. Contractor will remove glycol from chiller (possibly 400-500 lbs.) and dispose. Also, in Paragraph 24.A.1, the voltage will be revised to indicate 460v. This will be in Addendum.
- 2. Specifications Section 23 0508, Paragraph 8, will be changed as follows: Construction start will be changed to March 20, 2021 and completion will be changed to May 16, 2021.
- 3. Specifications Section 23 0508, Paragraph 8, will be revised by Addendum to reflect paragraph 2 above.
- 4. Be sure to add allowance to base bid.
- 5. A question was raised about installing a new refrigerant monitor to accommodate different refrigerant in chiller #1 and new chiller #2. Thomas Rockwell stated that a refrigerant monitor was not necessary.
- 6. Paragraph 27.1.a. will be revised to delete reference to "roof materials and flashing."
