- 1. Sidewalk and picnic slab replace what is removed, granular fill in, compact excavated areas.
- 2. Storm sewer is actually 40' west of where shown on plan. Plan will be revised in Addendum.
- 3. Site plan will be revised to indicate where the geo loop pipe will enter and exit the building. Bore field contractor will stop at outside flange. HVAC contractor will continue from flange and install metal casing and bore through masonry wall to bring into the building.

Bids are due by 2:00 p.m. Thursday, November 17, 2022 (prevailing time).
